## DISCLAIMER

### Disclosures, disclaimers and consent from the nominee/trustee-elects including those qualified for the vacancy positions.

The following Guidelines apply for the potential trustee-elect winners qualified for the vacancy positions during 2020 General Body Election conducted as per the Article III, Section 7(b), Article IV, Section 10 and Bylaw 34 of HTGC C & B revised 2018.

The board of trustees in order to bring clarity and transparency of our election process hereby discloses and proposes the following guidelines in electing eight trustees during 2020 GB Election to be conducted on the first Sunday of December.

### Trustees to be elected: Eight (8)

1. Patron Category: Five positions including two vacancies.
2. The board of trustees disclose that the eligible patron voters shall have a choice to select five trustees from the nominees on the ballot.
  - a. Of the five winners, the three candidates with highest number of votes shall be declared as the winners for the full terms of four years as per Article IV, Section 2 (a) & (b) of C & B.
3. The remaining two winners based on their number of votes shall fill in the two vacancy positions as per Article III Section 7 (b) and Article IV Section 10.

**Regular Category:** Three positions including two vacancies.

1. The board of trustees disclose that eligible voters shall have a choice to choose three trustees.
2. Of the three winners, the candidate with highest number of votes shall be declared as the winner for the full term four years as per the Article IV Section 2 (a) & (b).
3. The remaining two winners shall fill in the two vacancy positions for three-year terms as per Article III Section 7 (b) and Article IV Section 10.

The BOT hereby approves a provision to resolve in case of winners with Tie Votes for the assignment of vacancy terms as follows:

The qualified winners for the vacancy positions with **Tie Votes** shall agree to resolve by mutual agreement on the same day of election. In the event, qualified winners fail to reach an agreement among themselves on the same day of election, a Lottery system shall be carried out by the Chairperson of the Board of Trustees in the presence of the candidates for the vacancy terms.

### Unanimous Election Scenario:

**The BOT hereby approves a provision in case all patron category and all regular category candidates are elected unanimously:**

All trustee-elect applicants shall be given the First Choice to reach a mutual agreement among themselves on the same day of election. In case qualified winners fail to reach an agreement, a Lottery system shall be carried out by the Chairperson of the Board of Trustees for the assignment of the Terms in the presence of the trustee-elects and or their representatives

### Disclaimer statement:

The BOT hereby requests all nominees to review, acknowledge and consent to the above provisions approved by the board. with a disclaimer statement as follows:

All nominees in both categories shall hold HTGC and its board of trustees and its officers harmless for involuntary errors and or omissions; and also acknowledge that the nominees have read, understood, and will abide by the HTGC Constitution & Bylaws Revised in 2018
